

## NEW RIVER CDD POOL CARD REQUEST FORM AND POOL GUIDELINES

1. Pool hours: Dawn to Dusk
2. If you have an emergency, call 911
3. Members must have, always in their possession, their access card.
4. SWIM AT YOUR OWN RISKS. The pool area is not supervised by lifeguards.
5. The pool's emergency flotation rings are not to be used as a toy.
6. NO BBQ grills are allowed in the pool deck.
7. Members are responsible for cleaning up after themselves.
8. Animals are not permitted on the pool deck/area except for service animals.
9. Dives, flips, back jumps or other dangerous actions from pool side are prohibited.
10. Persons with open cuts, wounds, sores or blisters may not use the pool.
11. No person should use the pool with or suspected of having a communicable disease, which could be transmitted using the pool.
12. Glass containers or breakable objects of any kind are not permitted in the pool fenced in area but is permitted outside the pool fenced in area.
13. No food or beverage are allowed in the pool and or within 4 feet of the pool edge.
14. Appropriate swimming attire (swimsuits) must be always wore.
15. Infants/children not toilet trained, and incontinent persons must wear snug plastic or rubber pants under their swim suits when using the pool facilities. Diapers (cloth or disposable) are prohibited.
16. Pool may be closed due to weather warnings or general maintenance & repairs.
17. All swim instructors/independent contractors must be approved, insured and have a CDD contract.
18. In the event of rain, the pool is closed.
19. LIGHTNING - PLAN OF ACTION according to the NATIONAL LIGHTNING SAFETY INSTITUTE <http://lightningsafety.com> When lightning or thunder is observed everyone must EXIT THE POOL, POOL DECK & AVOID THE WATER. If lightning is striking nearby, you should *Avoid proximity* (minimum of 15 ft.) to other people or metal fencing. \*\*\*\*\* SUSPEND ACTIVITIES for 30 MINUTES after the last observed lightning or thunder.
20. Failure to abide by the rules may result in a warning and or immediate dismissal from the area and or 30-day suspension of amenity card, a \$25 reactivation fee and or Trespassing depending on severity of violation. Below is the suspension process, HOWEVER VIOLATIONS RELATED TO VANDALISM OR THE SAFETY AND HEALTH OF THE COMMUNITY AND ITS RESIDENTS WILL BE REVIEWED AND MAY RESULT IN ALL OF THE BELOW. All other general facility rules apply.
